BRIEF DESCRIPTION OF DUTIES: Incumbent will be responsible for the planning and conducting of an effective child development program to meet the physical, social, emotional and intellectual needs of each child in the program. Conducts appropriate play and learning activities to foster individual and group development. Interacts with children during programmed activities. Will review and implement daily schedules and activity plans. Demonstrates, instructs, leads, and facilitates planned and spontaneous programs. Helps prepare, arrange, and maintain indoor and outdoor activity areas and materials to accommodate daily schedules. Inventories equipment on a recurring basis. Completes and submits required reports in an accurate and timely manner. Collects, maintains, and reports program participation data. Provides care oversight and accountability of children that complies with established standards, policies, procedures and regulations. Adheres to child admission and release policies and procedures. **May perform other related duties as assigned.**

QUALIFICATION REQUIREMENTS: Prior experience working with children and/or youth preferred. At least 18 years of age and a high school diploma or equivalent. Ability to follow verbal and written instructions and to communicate effectively orally and in writing. Incumbent must have the ability to complete all training requirements within the specified timeframes, obtain a food handler's card, favorably pass a pre-employment physical and to satisfactorily complete background checks. Position is subject to special inoculation and immunization requirements as a condition of employment for working with children. Employee is required to obtain appropriate immunization against communicable diseases in accordance with recommendations from the Advisory Committee on Immunization Practices (ACIP), which includes the influenza vaccine.
